Notice is also hereby given pursuant Section 91 of the Companies Act, 2013, read with Rule 10(1) of the Companies (Management and Administration) Rules 2014 and clause 16 of the Listing agreement, the Register of Members and Share Transfer Books of the company will remain closed from Saturday, the 1st August, 2015 to Friday, 7th August, 2015 (both days inclusive) for the purpose of Annual General Meeting.

Members are hereby informed that in compliance with provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Clause 35B of the Listing Agreement, the Company is pleased to provide its shareholders the facility to cast their vote by electronic means on all the resolutions mentioned in the notice. The Company has engaged Central Depository Services (India) Limited (CDSL) to provide electronic voting facility to the members of the Company. Details pursuant to the Act are as under:

- a) A person, whose name appears in the Register of Members / beneficial owners as on the cut-off date, i.e. 31st July, 2015 only shall be entitled to avail of the facility of remote e-voting as well as voting at the AGM.
- b) The remote e-voting commences on Tuesday, 4th August, 2015 at 9.00 a.m. and will end on Thursday, 6th August, 2015 at 5.00 p.m. The remote e-voting shall not be allowed beyond the said date and time.
