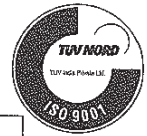

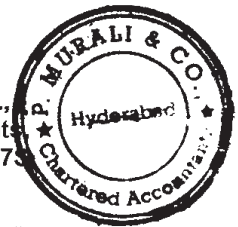
**Limited Review Report for the quarter ended 30<sup>th</sup> June, 2015**
