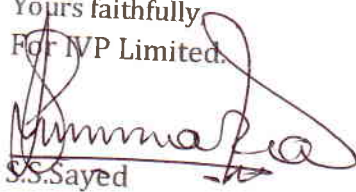
Outcome of the Annual General Meeting of the Members of the Company.
