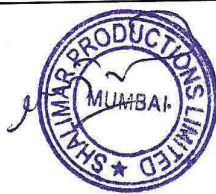

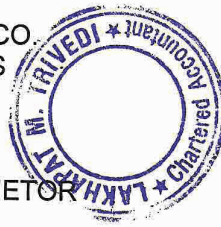
LIMITED REVIEW REPORT

We have reviewed the accompanying statement of unaudited financial results of **Shalimar Productions Limited** for the quarter ended **30th June, 2015** except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us.
