The Register of Members and Share Transfer Books will remain closed from September 24, 2015 to September 30, 2015 (both days inclusive) for the purpose of AGM and final dividend. The final dividend, on approval at the above AGM, shall be paid on or before October 20, 2015 as under;

- a) To all those beneficial owners holding shares in electronic form, as per the beneficial ownership details to be furnished by NSDL/CDSL as on September 23, 2015;
- b) To all those members holding shares in physical form, after giving effect to all valid share transfers lodged with the Registrar on or before September 23, 2015.
