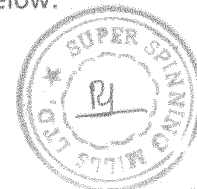

Sub: Scrutinizer's Report on Postal ballot and remote e-voting conducted pursuant to the provisions of Section 108 & 110 of the Companies Act, 2013 ("the Act") read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 - as amended and Clause 35B of the Listing Agreement

I, M D Selvaraj, FCS, Proprietor of MDS & Associates, Company Secretaries, Coimbatore, have been appointed by the Board of Directors of **SUPER SPINNING MILLS LIMITED** ("the Company") as the Scrutinizer for the purpose of scrutinizing the e-voting process and to scrutinize the Postal Ballot forms received from the shareholders in a fair and transparent manner and ascertaining the requisite majority on the Postal Ballot and remote e-voting carried out in accordance with the provisions of Section 108 & 110 of the Companies Act, 2013 read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 as amended and Clause 35B of the Listing Agreement in respect of the Special Resolution as set out in the Postal ballot Notice dated 10th August, 2015.



Responsibility of the Management

The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules made thereunder in relation to exercising of voting rights through Postal Ballot and electronic means on the Resolution as set out in the Postal ballot Notice dated 10th August, 2015.

Responsibility as a Scrutinizer

My responsibility, as a Scrutinizer for the Postal Ballot and for the e-voting process is restricted to the preparation of the Scrutinizer's Report of the votes cast "in favour" or "against" the Resolution set out in the Postal ballot Notice dated 10th August, 2015, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited (CDSL), the Authorised Agency engaged by the Company for providing e-voting facilities and of the Postal Ballot forms received upto Saturday 19th September 2015.

Further in addition to the above, I submit my report as under:

- On 19th August 2015, the Company has, through its Registrar and Transfer agents viz., M/s. Link Intime India Private Limited, Coimbatore, completed the dispatch / sending of Postal ballot Notice dated 10th August, 2015 and the reply envelope by Indian Post/e-mail to its shareholders whose names appeared on the Register of Members / List of Beneficiaries as on 14th August, 2015.
- The shareholders of the Company holding shares as on the "cut-off" date of 14th August, 2015 were entitled to vote on the proposed resolution as set out in item no. 1 of the Postal ballot Notice.
- The voting period for remote e-voting commenced on Friday, 21st August, 2015 at 09:00 Hours and ended on Saturday, 19th September 2015 at 17:00 Hours. The Postal Ballot forms received upto 17:00 Hours on Saturday, 19th September 2015 were considered for my scrutiny.
- I, as the Scrutinizer, unblocked the votes cast, on Saturday, 19th September 2015 after 17:00 Hours in the presence of Ms. Prerna Maheshwari (the



undersigned as Witness No.1) and Mr. A. Selten Jayaraj (the undersigned as Witness No.2), who are not in employment of the Company in accordance with Rule 20(4)(xii) of the Companies (Management and Administration) Rules, 2014 - as amended.
