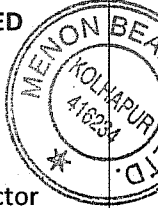

## Limited Review Report

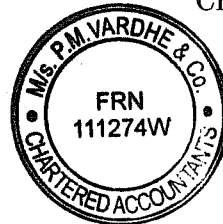
