Bhubaneswar, January 11, 2016: Ortel Communications Limited (Ortel), one of the leading cable television and high speed broadband services provider focused in the Indian states of Odisha, Chhattisgarh, Madhya Pradesh, Andhra Pradesh, Telengana and West Bengal, has introduced Wi-Fi Public Hotspot services for its Broadband subscribers. The Wi-Fi Hot Spot service has been launched as a special value added service.

Ortel is offering the Wi-Fi Hot Spot services in busiest locations of Bhubaneswar where people go for shopping and leisure. Ortel Broadband customers can avail these services “On the Go” through their Smartphones, Tablet PCs and Laptops.
