- 1. The Company seeks the consent of Members vide special resolution for following matters -

The Company has completed the dispatch of postal ballot forms along with postage prepaid business reply envelope on December 3, 2015 to its members whose name(s) appeared on the Register of members / list of beneficiaries and sent e-mail to all those members who had registered their e-mail ids with the company.


