KPTL RECEIVED NEW ORDERS OF APPROX. RS 1,295 CRORE

Mumbai, January 21, 2016: Kalpataru Power Transmission Limited (KPTL), a leading global EPC player in the power & infrastructure contracting sector has secured new orders/notification of award of approximately Rs 1,295 crore. Details are as follows:

- Establishment of Transmission system strengthening for transfer of power from New Hydro-electric power projects in Bhutan to India. The 400 KV transmission line project to be constructed in West Bengal and Bihar worth approximately Rs 864 crs has been awarded by the company's 100% subsidiary Alipurduar Transmission Ltd. This is the third BOOM project to be executed by the Company.
- Turnkey transmission line project in Nepal worth approximately Rs 238 crore from Nepal Electricity Authority.
- Construction of 380 KV overhead transmission lines in Saudi Arabia worth approximately Rs 146 crore. The project is implemented by Kalpataru IBN Omairah Company Limited, a joint venture between IBN Omairah Contracting Company and KPTL, where KPTL owns 65% equity stake.
- Transmission tower supply project worth approximately Rs 47 crore from Power Grid Warora Transmission Ltd (a wholly owned subsidiary of Power Grid Corporation of India Limited).

Commenting on the wins, Mr Manish Mohnot, Managing Director, KPTL said "The order inflow in the year till date is over Rs 6,150 crore which is over 1.4 times last year's revenues.
