The Chairman delivered his speech and thereafter informed the members that the Company had provided remote e-voting facility to the members as required by Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), to exercise their right to vote on the business items transacted at the AGM, by electronic means, between Tuesday, September 27, 2016 (9:00 am IST) to Thursday, September 29, 2016 (5:00 pm IST) in proportion to their shares held as on cut-off date of September 23, 2016 on all the Ordinary & Special Resolutions as set out in the Notice of AGM.Ms. Shruti H. Shah, Practicing Company Secretary (Membership No. 22923) was appointed as the Scrutinizer for providing facility to the members of the Company to scrutinize the voting and remote e-voting process in a fair and transparent manner.
 - 7. The Chairman than informed the members that those who had not voted through electronic means could vote through the Ballot Paper process to be conducted as per the requirements of the Companies Act, 2013 and the Rules made thereunder.
 - 8. Prior to the commencement of Ballot paper process, the Chairman requested to display the empty ballot box to the Members and Proxies present. The ballot box was then sealed in their presence.
 - 9. Mr. Dharmesh Anjaria, Executive Director, thereafter, took up items listed in the Notice one by one for transaction. The Chairman then requested the Members present, who had not exercised their vote through the remote e-voting facility, to cast their votes through Ballot Paper and deposit the forms into the Ballot Box.
