PROCEEDING OF THE 49th ANNUAL GENERAL MEETING OF THE COMPANY

The 49th Annual General Meeting of Ansal Properties & Infrastructure Limited {"the Company"} was held on Friday, the 30th day of September, 2016 commenced at 11.00 a.m. at Sri Sathya Sai International Centre, Pragati Vihar, Bhishm Pitamah Marg (Near ICICI Bank) Lodhi Road, New Delhi- 110003. Shri Sushil Ansal, Chaired the meeting. All the directors except Dr. Lalit Bhasin and Dr. R.C Vaish, Independent Directors were present in the meeting. The requisite quorum was present, therefore, the Chairman declared the Annual General Meeting {in short, "AGM" or "meeting"} open. The Chairman welcomed all Directors present on the dias.

The Chairman informed the members present in the meeting that the Register of Directors, Key Managerial Personnel {in short, KMP} and their Shareholding and the Register of Contracts/Arrangements in which Directors were interested pursuant to the provisions of Sections 170, 171 and 189 of the Companies Act, 2013 and the Rules framed there under and other documents {including Auditors and Secretarial Audit Reports} as mentioned in the Notice were kept open for inspection at the meeting and remained open and accessible to any person attending the meeting.

The Chairman addressed the members present through his speech and among others, appraised them of the overall progress made by the Company without any adverse effect during the Financial Year 2015-16 and the $1^{\rm st}$ Quarter ended on the $30^{\rm th}$ June, 2016 of the Financial Year 2016-17.

 - b. The shareholders of the Company as on the "cut-off date" i.e. 23^{rd} September, 2016 were entitled to vote on the resolutions (item no. 1 to 7 as set out in the notice of the $49^{rh}\Lambda$ GM of the Company).
 - c. At the venue of the AGM the facility to vote through Ballot papers was provided to those members who were present at the AGM and had not exercised the option of Remote E-voting.
 - d. After the time fixed for closing of the Poll by the Chairman, one ballot box kept for polling was locked in our presence with due identification marks placed by us.
 - e. The locked ballot box was subsequently opened in our presence along with two witnesses, Ms, Komal Bhola and Ms. Neha Lakhwara, who are not in the employment of the Company and the poll papers were diligently scrutinized. The witnesses have signed below in confirmation of the Ballot Box being unlocked in their presence.
