With Reference to above captioned subject matter and pursuant to Regulation 30 of SEBI (Listing Obligation & Disclosure Requirements) Regulations, 2015, and in continuation of our earlier disclosures made on 12th July, 2016 and 8th August, 2016, we would like to further inform & disclose that the Company has taken legal action by filing following legal cases & criminal complaint against the official and Directors of **Huntsman International (India) Private Limited, Mumbai, a part of Huntsman Corporation's Group of Companies (Huntsman Corporation, USA):**

- 1) Criminal & Cheating Complaint filed by the Company on 19th July, 2016 with Hon'ble Deputy Commissioner of Police of "Economic Offences Wing" (**E.O.W.**), **GC-III, Mumbai**, and the same has been registered with **E.O.W.** vide P.E. number 123/16 against the Officials of **Huntsman International (India) Private Limited, Mumbai**.
- 2) Summary suit filed by the Company against **Huntsman International (India) Private Limited, Mumbai** with Hon'ble Bombay High Court on dated 20th July, 2016 vide case no. COMS/53/2016 for recovery of its unpaid dues by **Huntsman International (India) Private Limited, Mumbai**.
- 3) Damage & Defamation suit filed by the Company against the **Huntsman International (India) Private Limited, Mumbai** with Hon'ble Bombay High Court on dated 8th


