Adlabs Entertainment Limited subsidiary inks LOI with Keystone Realtors (Rustomjee) & Axis Spaces for development of Township on surplus land.

Mumbai 27th October 2016: Adlabs Entertainment is pleased to inform that its wholly owned subsidiary Walkwater Properties Pvt Ltd (WPPL) has signed an Letter of Intent (LOI) with a consortium of Developers led by Keystone Realtors Pvt Ltd (Rustomjee) and Axis Spaces Pvt Ltd for developing a mixed use residential township on part of surplus land near the theme park *Imagica*.

Under the LOI, WPPL will provide part of the surplus land of 88 acres to the developers for development, marketing and sales of the residential township. The LOI also provides usage of brand name 'Rustomjee' for the project. The detailed agreements and other terms and conditions of the joint development are under negotiations and shall be finalised in due course.

WWPL had earlier received the locational clearance for a special township of 88 acres out of the total surplus land of 170 acres held by WPPL. The company is in the process of obtaining approvals for the balance surplus land as well.

The 10 km radius around Khalapur where *Imagica* is located is seeing substantial real estate development with some large projects underway in brisk pace developed by some marquee real estate companies. With the new airport project and other infrastructure project being put on the fast track by the government it is expected that the region will become the epicentre of new development.
