- Themis Medicare Limited has recorded consolidated income from operations of Rs. 60.29 Crores during the quarter ended 30<sup>th</sup> September, 2016 as against Rs. 63.87 Crores during the corresponding quarter last year (On Half yearly basis the Consolidated Income recorded at Rs. 127.42 Crores as against Rs. 123.38 Crores during the corresponding period of last year).

The Standalone income from operations amounted to Rs. 56.43 Crores during the quarter ended 30<sup>th</sup> September, 2016 as against Rs. 56.43 Crores during the corresponding quarter last year (On Half yearly basis the Standalone Income recorded at Rs. 113.23 Crores as against Rs. 107.96 Crores during the corresponding period of last year).

- The Consolidated Net profit earned including share of associates is Rs. 6.98 Crore against Rs. 6.59 Crore during the corresponding period last year. (On Half yearly basis the Consolidated Net Profit earned was Rs. 14.33 Crores as against Rs. 12.43 Crores during the corresponding period of last year).

The Standalone Net profit earned is Rs. 7.07 Crore against Rs. 4.65 Crore during the corresponding period last year. (On Half yearly basis the Standalone Net Profit earned was Rs. 12.57 Crores as against Rs. 8.67 Crores during the corresponding period of last year).
