

## Garware-Wall Ropes Q2 FY17 net profit jumps 69% to Rs. 26 crore

**Pune, November 12, 2016:** Garware-Wall Ropes Ltd. (GWRL), a leading manufacturer of technical textiles for the Indian and global markets, today announced its financial results for the second quarter ended September 30<sup>th</sup>, 2016.

### **Q2FY17 Highlights:**

- Net Sales grew by 8.4% to Rs. 232.1 Cr in Q2 FY17 as compared to Rs. 214.1 Cr in Q2 FY16
- Profit before tax grew by 78% to Rs. 38.1 Cr in Q2 FY17 as compared to Rs. 21.4 Cr in the same quarter last year
- Net profit after tax has grown by 69.3% to Rs. 26 Cr in the quarter as against Rs. 15.4 Cr in the corresponding period of FY16
- EPS for Q2 FY17 is at Rs. 11.89; this is a growth of 69.3% over Q2 FY16

### **H1FY17 Highlights:**

- Net Sales improved by 0.8% to Rs. 456.9 Cr in H1 FY17 as against Rs. 453.2 Cr in H1 FY16
- Profit before tax grew by 54.4% to Rs. 66.5 Cr as compared to Rs. 43.1 Cr in H1 FY16
- Net profit after tax has grown by 52.6% to Rs. 45.8 Cr as against Rs. 30 Cr in the corresponding period last year
- EPS for the H1FY17 is at Rs. 20.92; this is a growth of 52.6% over H1 FY16
