Mr. Kulin Lalbhai has no relationship with the other Directors on the Board.

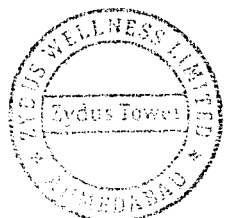
