We have reviewed the accompanying statement of unaudited financial results of FOODS AND INNS LIMITED ("the Company") for the quarter and half year ended September 30, 2016, prepared and being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, which has been initialed by us for the identification purpose. This statement is the responsibility of the Company's Management and has been reviewed by the Audit Committee and approved by the Board of Directors, in their respective meetings held on November 12, 2016. Our responsibility is to issue a report on the statement based on our review.

During the quarter ended on September 30,2016, the Company had issued 36,000 Convertible Warrants ("Warrants") on a preferential basis to a Promoter against which it received a sum of ₹ 64,80,000 , being 25% of the price fixed against such Warrants. Each Warrant carries a right to convert the same into one Equity Share of ₹ 10 each at a premium of ₹ 710 each (calculated as per the formula prescribed in accordance with Chapter VII of SEBI ICDR Regulations) over a period of 18 months from the date of allotment.

 6. During the quarter ended on September 30,2016, the Company had issued 1,00,000 equity shares of ₹ 10 each at a premium of ₹ 710 on a preferential basis resulting into increase in paid up Equity
- Share Capital and Securities Premium Account by ₹ 10,00,000 and ₹ 7,10,00,000 respectively.

 - For the year ended March 31, 2016 Includes ₹ 338.31 Lacs, For the quarter and half year ended September 30, 2015 ₹ 129.56 Lacs.
