New Delhi, November 11, 2016: The Board of Directors of Sona Koyo Steering Systems Ltd. Standalone

For the quarter ended 30th September, 2016, Net Sales has increased by 4.9% to Rs 283.4 Crores as compared to Rs. 270 Crores during the same period last year. Profit after Tax increased by 17.2% to Rs. 6.1 Crores against Profit of Rs. 5.2 Crores during the same period last year.

For the Half year ended 30th September, 2016, Net Sales has increased by 3.4% to Rs 545.9 Crores as compared to Rs. 527.9 Crores during the same period last year. Profit after Tax increased by 32.2% to Rs. 9.2 Crores against Profit of Rs. 6.9 Crores during the same period last year.

Consolidated

For the quarter ended 30th September, 2016, Net Sales is Rs 385 Crores as compared to Rs. 387.1 Crores during the same period last year. Profit after Tax is Rs. 6.1 Crores against Profit of Rs. 6.6 Crores during the same period last year.

For the Half year ended 30th September, 2016, Net Sales is Rs 731.4 Crores as compared to Rs. 759.5 Crores during the same period last year. Profit after Tax is increased by 4.89% to Rs. 11.3 Crores against Profit of Rs. 10.8 Crores during the same period last year.
