The Statement on Investors' Grievances Redressal was placed before the Board in its meeting held on Wednesday, October 12, 2016.

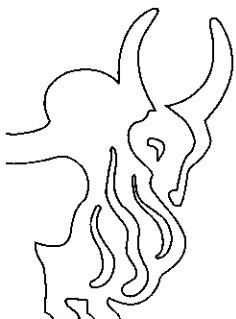
