Sub: Announcement of Postal Ballot results



Sub : Scrutinizer's Report on Postal Ballot

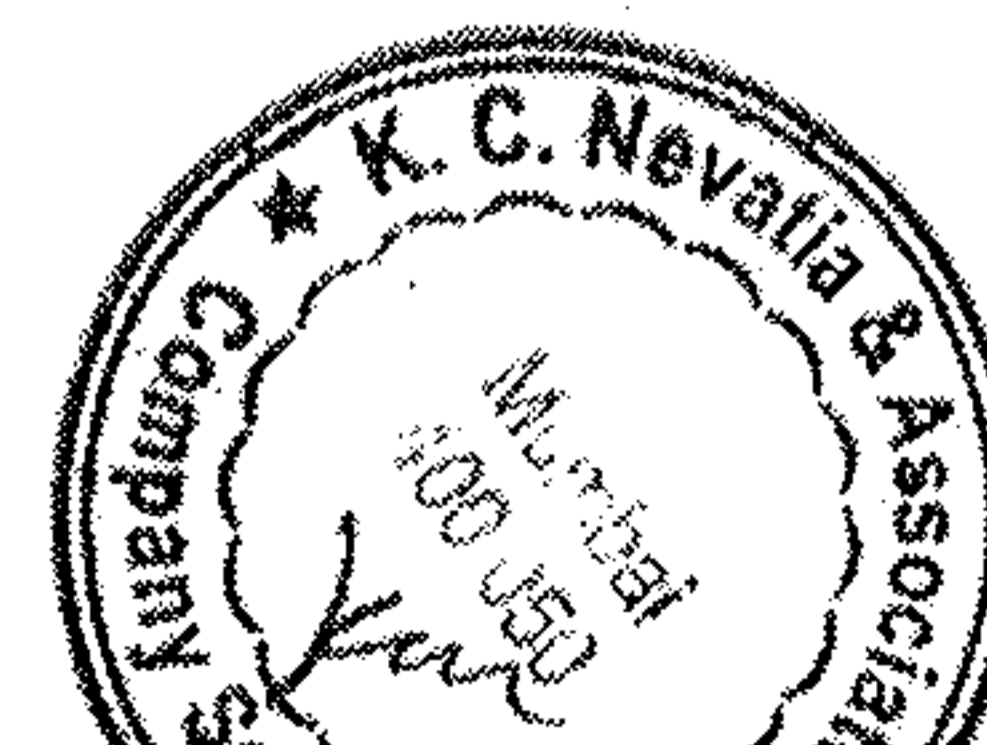

3. No postal ballots were found incomplete and/or defective or invalid and thus all the postal ballots were treated as valid.



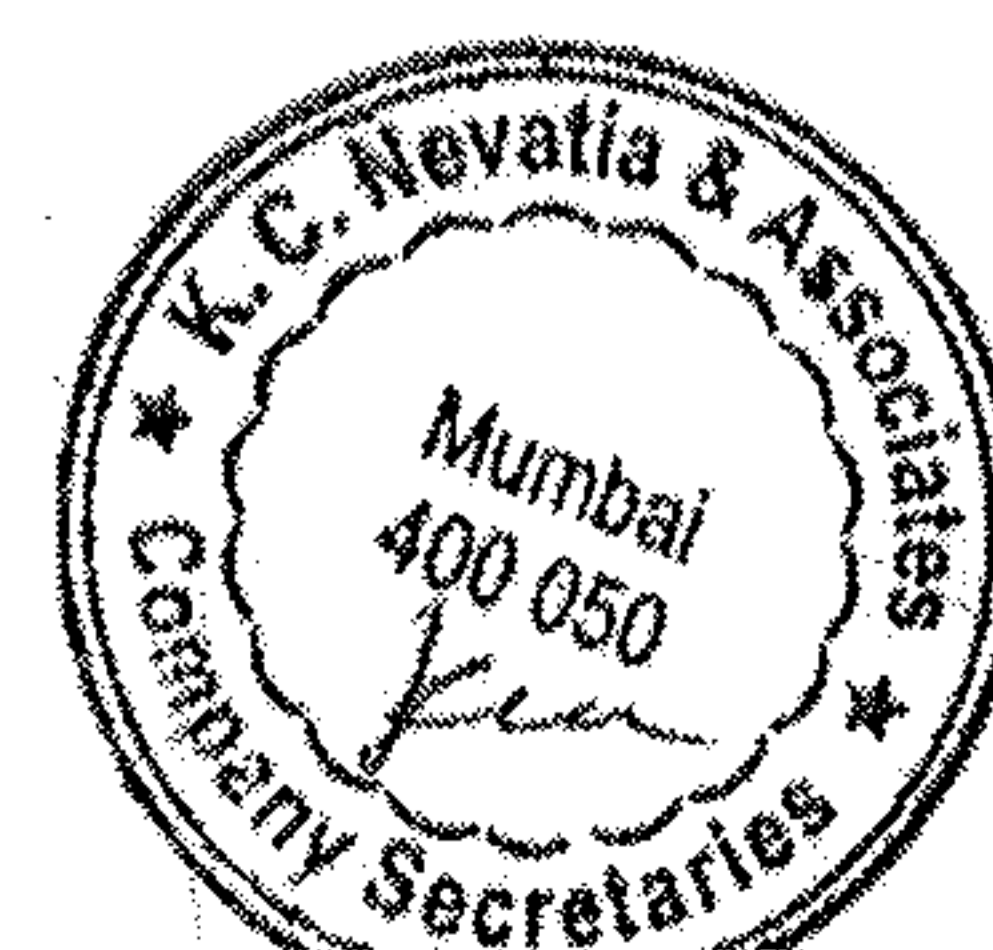
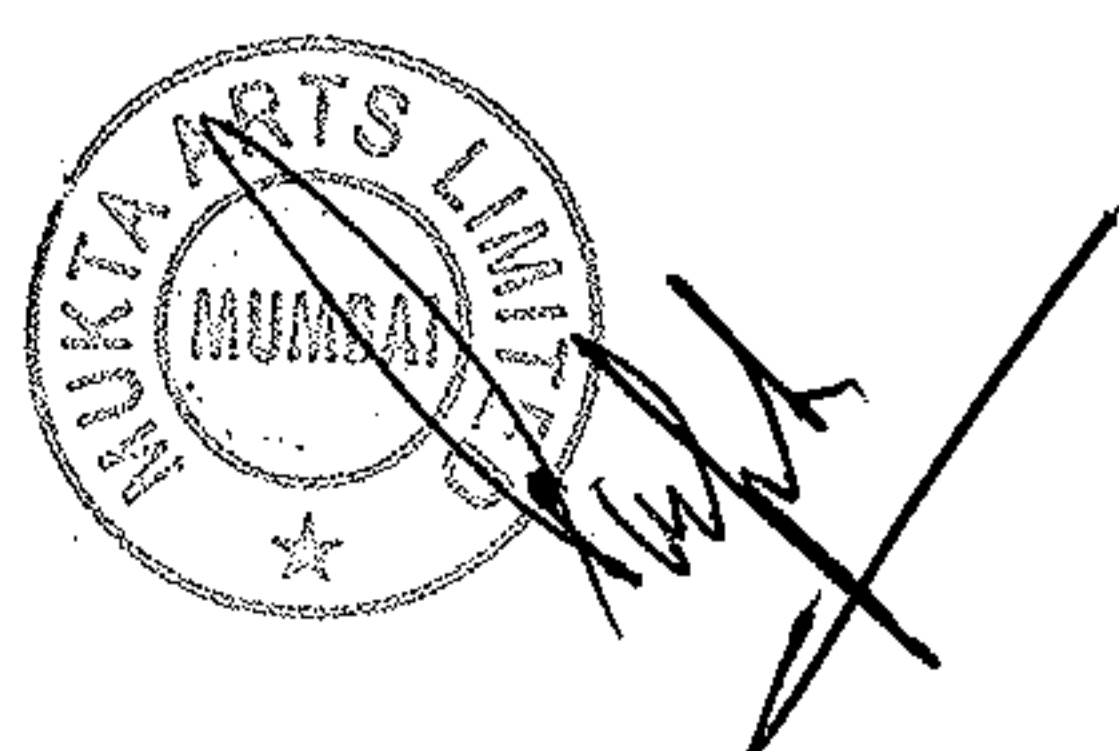

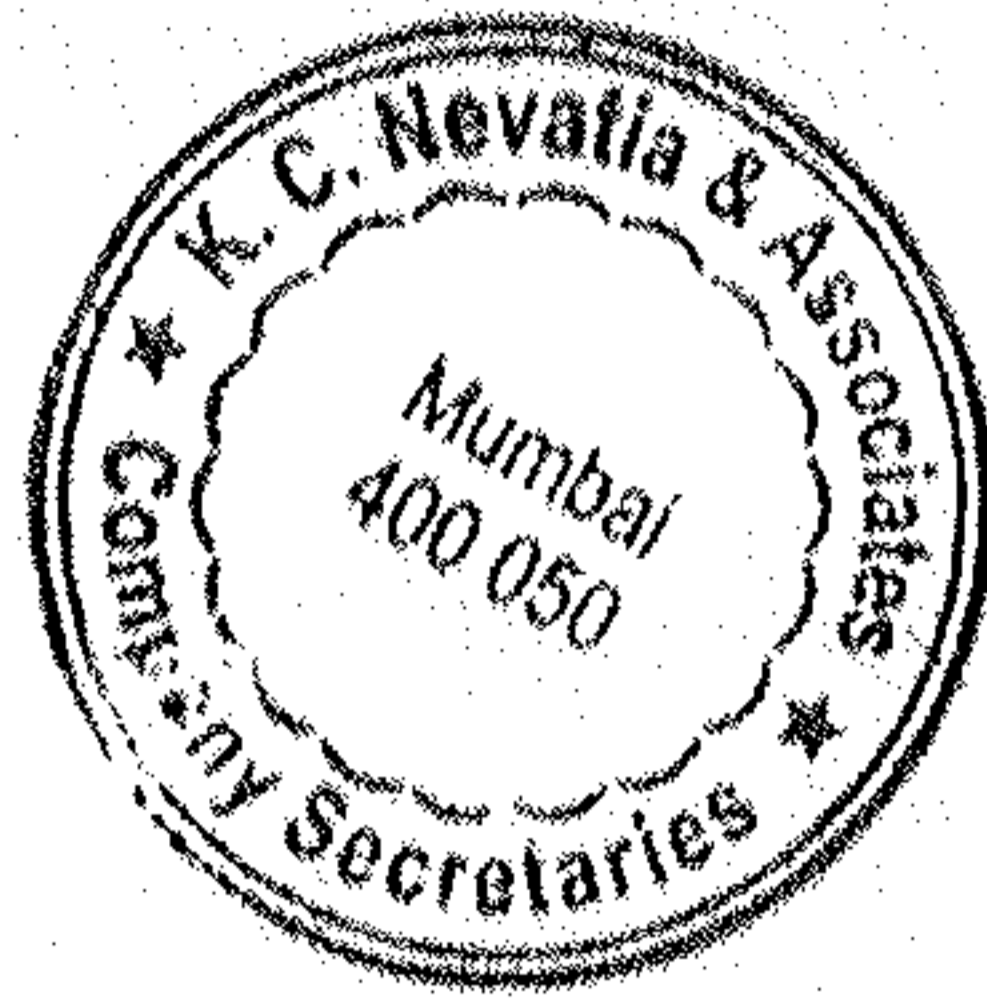
