**Ahmedabad, December 07, 2016:** Further to its announcement on 5<sup>th</sup> October, 2016, Adani Transmission Limited executes the definitive document, i.e. the Share Purchase Agreement (SPA) with Reliance Infrastructure Limited (R-Infra) for 100% acquisition of Western Region System Strengthening Scheme (WRSSS) TRANSMISSION ASSETS of approximate 3100 Ckt Kms.

The Enterprise Value (EV) of WRSSS Transmission Business is ~Rs. 1000 Crore.
