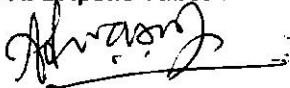

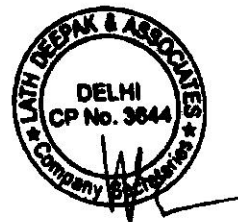

re-enactment(s) thereof for the time being in force, the Board of Directors of APL Apollo
Tubes Limited (the Company), appointed me as the Scrutinizer for conducting the Postal
Ballot process (including voting through electronic means) for passing of Special

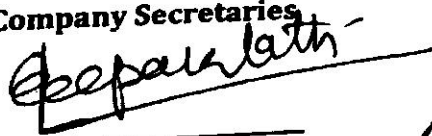

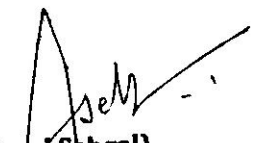
