We are the member of promoters / promoter group of the Company. Our shareholding pre-acquisition was 1275777 equity shares of Rs. 10/- each of the Company constituting 16.854% of the total paid up capital of the Company. We have acquired total 1890152 equity shares (as 24.97% of paid up share capital of the Company) of Rs.10/- each of the Company pursuant to inter-se transfer of these shares amongst promoters / promoter group of the Company under regulation 10(1)(a) of the Regulations. Consequently, we are now holding, post this acquisition through inter-se transfer between promoters / promoter group of the Company, total 3165929 equity shares of Rs. 10/- each of the Company constituting 41.83% of the total paid up capital of the Company. However, the shareholding of the promoters / promoter group of the Company which is currently is 74.81% of the paid up share capital of the Company remains unchanged after the acquisition of the shares pursuant to this inter-se transfer amongst promoters / promoter group of the Company and hence, this transaction will not result in any change of control of promoters / promoter group over the Company. **There is no change in the control of the Company.**
