## Blue Star to set up two new state-of-the-art manufacturing facilities at Jammu and Sri City

Blue Star Limited has announced that it is in the process of setting up two major manufacturing facilities to redesign and augment its manufacturing footprint. These will be located at Samba in Jammu and Sri City in Andhra Pradesh. The Company plans to invest Rs 215 crores over the next 3-4 years towards this exercise which will increase its overall production capacity by about a million units towards the final phase.

Blue Star had embarked on a manufacturing footprint programme with the help of KPMG. Consequent to that exercise, the Company closed down its Thane and Bharuch plants. Thus, currently, the Company has five plants in Wada, Dadra, Ahmedabad and Himachal Pradesh. Whilst the Plant at Sri City is proposed to be built around an area of around 20 acres, the Samba factory is to be constructed over 24 acres. These factories will primarily manufacture room airconditioners, deep freezers and water coolers.

The facility at Samba would enable the Company to avail of the excise duty exemption for a period of 10 years from the commencement of production. Apart from planning to avail State GST benefits for intrastate sales, the Sri City Plant would lead to considerable savings in logistics costs since a significant proportion of airconditioner sales of the Company is from the South. It would also de-risk the products business due to the spread of its manufacturing footprint in two different states. The significant enhancement in Blue Star's manufacturing capacity will help cater to the burgeoning demand in the domestic as well as export markets. Procurement of land followed by plant construction is proposed to start immediately for Samba to enable it to commence operations by FY18. Land procurement is expected to begin at the earliest for Sri City with the plant

construction planned in a phased manner to start operations by FY19.

The new factories are planned to be world-class manufacturing hubs with superior

aesthetics and ergonomics, deploying state-of-the-art technology. These modern and

contemporary plants will ensure that the products manufactured are not only globally

competitive but also set new benchmarks in manufacturing technology in the country. The

Company aims to transform into a digital enterprise by progressively building on smart

manufacturing with Wi-Fi enabled products, inverter technology, vertical integration and

environment-friendly products. Further, it intends to develop these plants as

environmentally responsible and ecologically sustainable.

Limited adds, "A detailed evaluation was undertaken by comparing qualitative parameters

such as industrial location and quality of life, supplemented by multiple field visits by the

project team to gather ground level insights. Blue Star will scale up its manufacturing

operations considerably with fully integrated factories at Samba and Sri City to become the

largest Indian manufacturer in the AC&R industry. The Company is keen to introduce the

best of automation in these new facilities, actualising the country's vision of 'Make In India'.

The integrated manufacturing strategy from design to lifecycle is envisaged to be one of

its kind in the AC&R industry."
