SCRUTINIZER'S REPORT

Report to the Chairman of the Board of Directors of M/s. Onelife Capital Advisors Limited (CIN L74140MH2007PLC173660), a Company incorporated under the Companies Act, 1956 and having its Registered Office at 307, Raut Lane, Opp. ISKCON, Vile Parle (W) Mumbai-400049, Maharashtra (hereinafter referred to as 'the Company') on the **POSTAL BALLOT** conducted by the Company to approve the businesses as mentioned in the Notice of Postal ballot dated 11.12.2015.

- 1. Pursuant to the provisions of the Section 27, 13 & 186 and all other applicable provisions of the Companies Act, 2013 and Rules made thereunder (including any statutory modification/s or re-enactment thereof for the time being in force), approval of the shareholders was sought for altering the objects of the initial public offer and approval for making investments, providing loans, guarantees and securities beyond the prescribed limits.
- 2. In terms of provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, I was appointed as Scrutinizer by the Company on 11.12.2015 to conduct the Postal Ballot for passing of the Special Resolution as contained in the Notice dated 11.12.2015.

- 5. I received 20 Postal Ballot Forms and 5 Members cast their votes on the e-Voting platform, till 5.00 P.M. IST on 12th February 2016, being the last day for receipt of duly completed Postal Ballot Forms and e-Voting on NSDL and CDSL portal, as per said Notice.
- 6. With the support of M/s. Sharepro Services (India) Pvt. Ltd., the Registrar & Transfer agents (RTA) of the Company, the Postal Ballot Forms were scrutinized and signatures of Members who had cast their votes were verified with their specimen signatures registered with Company and as provided by the Depositories.
