As per the latest available balance sheet of SSWL as at March 31, 2015, its net worth has been eroded. However, in view of the long-term strategic nature of the investment and the future growth prospects of SSWL, no provision for diminution in the value of the investment and for the unsecured loans is considered necessary at this stage.
