





1. Appellants in all these appeals have challenged the orders passed by the Securities and Exchange Board of India ("SEBI" for short) which are impugned in the respective appeals, whereby each appellant is

directed to make restatement of financial statements for the financial years set out in the respective orders.

2. Counsel for SEBI on instruction state that in view of the resolution passed in the SEBI Board Meeting dated March 12, 2016 and the subsequent press release issued to that effect on March 12, 2016, the impugned orders may be quashed with liberty to SEBI pass appropriate orders in accordance with law.


3. Accordingly, orders impugned in these appeals are quashed and set aside with liberty to SEBI pass fresh order on merits and in accordance with law. All contentions on both sides are kept open.

4. All the appeals are disposed of in the above terms with no order as to costs. In view of disposal of Appeal No. 451 of 2014, Misc. Application No. 214 of 2014 filed in that appeal does not survive and is accordingly disposed of with no order as to costs.
