Sub: Receipt of LOA by JV of the Company for Transmission Line works in Gujarat worth Rs. 153.99 Crores

Ref: Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is to inform that IL&FS Engineering and Construction Company Limited (The Company) and Unitech Power Transmission Limited JV has received Letter of Award (LoA) for Rs. 153.99 Crores Turnkey Works of 765 kV Transmission Line in Gujarat from Power Grid Corporation of India Limited (PGCIL).

The scope of work includes Supply Contract for Tower Package-TW02 for 765kV D/C Bhuj-Banaskanta Transmission Line (Part-II) associated with Green Energy Corridors: Inter-State Transmission Scheme (ISTS) – Part C along with contract for construction works of this Line in the state of Gujarat. The total value of this contract is Rs. 153.99 Crores, and the project completion period is 24 months from the date of issue of the LOA.

This contract has been won under International Competitive Bidding (ICB) process, and the project is funded by The KFW Bank.


The Company has executed Transmission Lines, Sub Stations and Distribution Works in the states of Andhra Pradesh, Telangana, Uttar Pradesh, West Bengal, Haryana, and Karnataka.

The Company is currently executing Rural Electrification (RE) works in state of Uttar Pradesh for Paschimanchal Vidhyut Vitran Nigam Limited (PVVNL) worth around Rs. 389.28 Crores, and for Madhyanchal Vidyut Vitran Nigam Limited (MVVNL) worth Rs. 474.92 Crores in the state of Uttar Pradesh.

The Company is also executing RE works for West Bengal State Electricity Distribution Company Limited (WBSEDCL) in the state of West Bengal worth more than Rs. 600 Crores for 3000 villages.
