Glenmark Pharmaceuticals receives another two ANDA approvals from the U.S. FDA

• In addition to an injectable approval, Glenmark also received ANDA approvals from the U.S. FDA for two Oral Contraceptives – Drospirenone and Ethinyl Estradiol Tablets USP, 3 mg/O.03 mg and Levonorgestrel Tablet, 1.5 mg

Mumbai, March 28, 2016: Glenmark Pharmaceuticals Inc., USA (Glenmark) has been granted final approval by the United States Food & Drug Administration (U.S. FDA) for Drospirenone and Ethinyl Estradiol Tablets USP, 3 mg/0.03 mg, the generic version of Yasmin® Tablets of Bayer HealthCare Pharmaceuticals Inc. (Bayer) and for Levonorgestrel Tablet, 1.5 mg, the generic version of Plan B One-Step® Tablet of Teva Branded Pharmaceutical Products R&D, Inc., for over-the-counter (OTC) use as recommended in the submitted labeling.
