1. Approval to the Scheme of Reduction of Capital of the Company to write off Goodwill and Accumulated Losses against the balance lying in securities premium account of the Company.


It is to be noted that the Scheme of Reduction of Capital does not involve reduction in the issued, subscribed, paid up share capital of the Company.

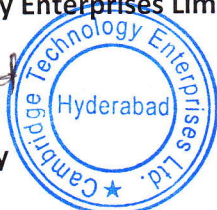
