Mr. Rajendra S Pawar, Chairman of the meeting informed that, pursuant to Section 110 and other applicable provisions, if any, of the Companies Act, 2013 (the Act) read with Companies (Management and Administration) Rules 2014, Postal Ballot notice dated February 10, 2016 (with Postal Ballot Form) was sent to the Shareholders of the Company for their assent or dissent on the following item:

"To authorize the Board of Directors to make investments or give loans /guarantees or provide securities in connection with a loan."
