Ltd., (Sharepro) inter alia restraining Sharepro and several activities linked with the management of Sharepro from buying, selling, or dealing in the securities market or associating themselves with securities market, either directly or indirectly, in any manner.

Further, SEBI has advised to all the client companies of Sharepro to carry out/ switchover their activities related to a registrar to an issue and share transfer agent, either in-house or through another registrar to an issue and share transfer agent registered with SEBI.

In view of the aforesaid, today 1<sup>st</sup> April, 2016 the Board of Directors of the Company have approved the proposal for appointment of **M/s. Link Intime India Pvt. Ltd.** having their registered office at C-13, Pannalal Silk Mills Compound, LBS Marg, Bhandup (West), Mumbai: 400078 as the as Registrars & Share Transfer Agents of the Company (Common agency for Share registry work) in place of Sharepro.
