

This is to notify you that your Tender for the work under reference has been accepted by the Competent Authority of IRCON for a total Contract Price of Rs. 53,91,38,184.00 (Indian Rs Fifty three Crores Ninety one Lakhs Thirty eight Thousand One hundred Eighty four only) in its capacity as an Agent /Power of Attorney Holder acting for and on behalf of NTPC LIMITED (the Employer). Some of the main / important terms & conditions are given below for ready reference and compliance.

SCOPE OF WORK:

The scope of work under this LOI covers Execution of all works of Package-1 of private railway siding with all Contractor's materials (except Rails for plain track issued free of cost) for coal transportation system for Darlipali STPP of NTPC Limited in Sundergarh Distt in Odisha State(from Ch. 6.000toCh.12.460–Pkg.1) in Darlipali- Dulanga MGR sectionas as per the approved methodology and as per direction of IRCON Engineer. Detailed scope of work is given in clause 3.0 of Special conditions of Contract. It is a Railway siding and the work has to be carried out completely as per Indian Railway Rules/Specifications as it will be responsibility of the contractor to get the final work approved from Railway.

2. ACCEPTED RATES

- 2.1 The accepted rates for the various items are stipulated in the Schedule of items and Quantities which will be enclosed at Annexure I to LOA.
- 2.2 The above accepted rates are firm and fixed till the completion of execution of entire quantity of work and acceptance of it by Railway/NTPC and no price escalation for whatsoever reasons shall be admissible.

3. Other conditions:

- 3.1 You are requested to submit the following within 28 days of issue of letter of award but before signing of the Agreement, whichever is earlier:
 - a. Performance guarantee for an amount of `26956910/- (Rupees Two Crores Sixty Nine Lacs Fifty Six Thousand Nine Hundred and ten only i.e. 5% of the contract value 539138184.00) valid **initially** up to 60 days beyond the date of completion in terms of sub-clause no.: 42.2 of Special Conditions of Contract.
 - Detailed Methodology and Work programme in bar chart as per Clause no.:3.14 of Special Conditions of Contract.
 - c. Stamp paper of requisite value as per Clause no.:29.3 "Instruction to tenderer"
- You are requested to attend this office on or before 28.05.2016 for signing of the Contract Agreement (i.e. a date within 28 days of issue of letter of award as per clause no.:29 of "Instruction to tenderer").
- 3. You are requested to commence the work immediately. The entire work shall be completed within a period of 12 (Twelve) months including monsoon period from the date of issue of this LOA.
- 4. In terms of clause 9 of "Instruction to tenderer" the Earnest Money Deposit of `38,89000/- (Rs. Thirty Eight Lacs and Eighty nine Thousand Only) submitted by you in the form of FDR along with your offer, has been retained towards retention money till the equivalent amount is deducted from first on account bill. Further deduction of retention money shall be recovered from your on-account bills @ 10% of the gross value of each on account bill till the sum total of retention money reaches 5% of the contract value of the work. (Clause No.9.3 of "Instruction to tenderer")
- 5. All other terms and conditions contained in the e-tender documents dated 12.01.16 shall form part and parcel of the contract.
