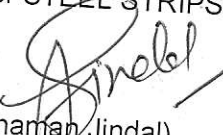

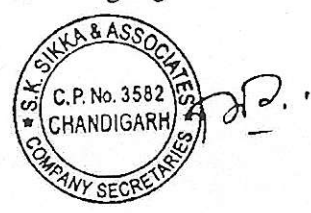
Sub: Passing of Resolutions through e-voting and poll conducted at the First Extra ordinary General Meeting of STEEL STRIPS WHEELS LIMITED
