In terms of the provisions of Section(s) 108 and 110 of the Companies Act, 2013 (hereinafter referred to as the "Act") read with the Rules 22 and 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, I have been appointed as Scrutinizer by **RELIGARE ENTERPRISES LIMITED** ('the Company') on Friday, May 27, 2016 to conduct the Postal Ballot/ e-voting process in a fair and transparent manner in respect of the following resolutions:

I submit my report as under:

- 1. The Company completed dispatch of postal ballot notice(s), postal ballot forms and postage prepaid business reply envelope(s) on Thursday, June 16, 2016 to its Members whose name(s) appeared in the Register of Members as on Friday, June 03, 2016.
- 2. The Company has made advertisement regarding dispatch of postal ballot notice and ballots in English Daily "The Financial Express" and in Hindi Daily "Jansatta" on Friday, June 17, 2016.
- 3. The shareholders of the Company had option to vote either through the postal ballot and forms or through the e-voting facility. Shareholders who opted for e-voting facility, cast their votes on the designated website i.e. https://evoting.karvy.com via Karvy Computershare Pvt. Ltd.("KARVY") e-voting platform.
- 4. The physical Postal Ballots received by post/courier/by hand were kept under my safe custody in sealed and tamper proof ballot box before commencing the scrutiny of such postal ballots. The e-voting was maintained by KARVY in electronic registry.
- 5. I monitored the process of e-voting through the scrutinizer's secured link provided by KARVY on the designated website.
- 6. The ballot box was opened on Saturday, July 16, 2016 after 5.00 P.M. in my presence and the e-votes were unblocked on Saturday, July 16, 2016 after 5.00 P.M. in the presence of two witnesses, Mr. Dhiraj Kheriwal R/o 11/170, Amrit Puri, Near Iskcon Temple, New Delhi-110065 and Mr. Piyush Garg R/o B-29, East Jyoti Nagar 2nd Floor, Back Side Near Jyoti Nursing Home, New Delhi-110093 who are not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.

- 7. The particulars of all postal ballots received from the Members in physical form(s) as well as e-voting report generated from KARVY have been entered in a separate Register maintained for the purpose.
- 8. All postal ballots received and e-votes cast up to 5.00 P.M. on Saturday, July 16, 2016 i.e. the last date and time fixed by the Company for receipt of the postal ballots were considered and none of the envelopes containing postal ballots received after 5.00 P.M. on Saturday, July 16, 2016 were considered for the purpose of this report.
- 9. The postal ballots and e-votes were matched with the Register of Members of the Company as on Friday, June 03, 2016.
- 10. There was nil envelopes containing postal ballot form(s)/Notice(s), which were returned undelivered.
- 11. I did not find any defaced or mutilated postal ballots.
- 12. The shareholders exercised their voting either by e-voting or postal ballots.. There was no shareholder who opted for both the facilities.
- 13.
