- 1. We have been appointed by M/s. Ratnamani Metals and Tubes Limited (hereinafter referred to as "the Company") (CIN: L70109GJ1983PLC006460) to carry out audit of records and systems of Sharepro Services (India) Pvt. Ltd. (hereinafter referred to as "Sharepro") acting as registrar and share transfer agents (hereinafter referred to as "RTA") of Ratnamani Metals and Tubes Limited ("Ratnamani"), in terms of SEBI Exparte Interim Order bearing No. WTM/RKA/MIRSD2/41/2016 dated 22nd March, 2016 by which SEBI has SEBI had directed all listed companies that engaged Sharepro as their RTA to conduct independent audits of Sharepro's records to ascertain if the shares and dividends were transferred to actual holders as per law.
- 2. Sharepro were appointed as Registrar and Share Transfer Agent of Ratnamani with effect from at April, 2010. Earlier, the Company's Registrar and share Transfer Agents were Pinnacle Shares Registry Private Limited.
- 3. As the scope of audit was not specified, we have taken reference of the para 11 of the said order, which reads as under:

"Companies who are clients of Sharepro are directed to conduct a thorough audit of the records and systems of Sharepro with respect to dividend paid and transfer of securities to determine whether securities have been transferred as per provisions of law. This audit should cover the dividends paid/ transfers effected within the preceding at least 10 years. The audit directed above shall be completed by companies within a period of three months from the date of this order and thereafter a report shall be submitted to SEBI by companies in that regard. Further, within a period of six months from the date of this order, the companies shall take appropriate action, in case where violations are observed, in accordance with the provisions of law and inform SEBI accordingly.

- 4. Accordingly, we have carried out the comprehensive audit with an objective to determine whether:
 - Dividends have been paid to the actual / beneficial holders, whose names were (i) appearing in the Register of Members for the shareholders holding shares of the company as on the record date/ book closure date and/or the beneficiary data provided by the Depositories for the purposes of payment of dividends;
 - Securities have been transferred as per the prescribed procedure under the applicable (ii)
- 5. As the Sharepro were appointed as RTA/STA from 1st April, 2010, we have verified the relevant records for the period from 1st April, 2010 to 31st March, 2016.
- 6. Considering he above objective, we have verified the various records and systems at the Ahmedabad office of Sharepro and obtained soft copies of the data as were required to conduct our audit under terms of reference.
- 7. We have also obtained the list of past and present employees of sharepro at Ahemdabad office to verify whether any of them was holding any shares at any time during relevant period, shares were transferred in their names and/ or dividend were paid to any of them. (Annexure: A)
- 8. We have also checked the similar data for the promoters and other employees of Sharepro whose names were included in the SEBI order.
- 9. None of the Ahmedabad employee or the persons named in SEBI Orderwere found to be shareholder of Ratnamani during relevant period, nor any dividend was paid to them by the Company.
- 10. It was noticed that Sharepro had adopted a standard practice of giving seller advice in case of transfer request to the first named transferor shareholder. In one such case when the share transfer request was made from "A" and "B" to "A" and "C", the seller advice was given to "A" and after expiry of the period mentioned in the advice, transfer effected was given. In such case as the name of B is replaced in favour of C, the advice should heve also been given to B.
