BUSINESS UPDATE:

- An observation letter has been received from the Designated Stock Exchange, BSE approving, in principle, the merger of Phoenix Lamps Limited with the Company, subject to certain conditions which have been met with. The Company and Phoenix Lamps Limited propose to approach the High Court of Karnataka to implement the merger scheme. The necessary meetings of the shareholders and creditors will be convened based on the direction from the Hon'ble High Court of Karnataka seeking approvals for the merger of Phoenix Lamps Limited with Suprajit Engineering Limited.
- The minority shareholders of Phoenix Lamps Limited are entitled for the final dividend recommended by Suprajit Engineering Limited, (Re. 0.55 per share of Re. 1/-) post the merger, subject to necessary approvals.
- In continuation of establishment of a branch office in US, and to further explore the opportunities of expanding the business in the North America, Suprajit has now established Suprajit USA Inc, a wholly owned company in USA.
- Commercial production at the new plant, at plot No. G28 & G29, SIPCOT Industrial Area, Vallam Vadagal, Sriperumbudur Taluk, Chennai, has started and commenced supplies to a marquee customer in Tamil Nadu.
