In terms of provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 I was appointed as the Scrutinizer by the Company on 4<sup>th</sup> July, 2016 for conducting the Postal Ballot and e-Voting process and furnish my report for obtaining the approval of members for the Special Resolution as set out in the Notice dated 4<sup>th</sup> July, 2016

I submit my report as under:

- 1. On the basis of the Register of Members and the List of Beneficiary owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on 8<sup>th</sup> July, 2016 the Company completed dispatch of the Notice of Postal Ballot on 12<sup>th</sup> July, 2016:
  - by email to 50,299 members who had registered their email ids with the Company or as provided by the Depositories or the Registrar and Share Transfer Agents and also in Physical Form by Registered Post.
  - by Courier to 35,062 members in Physical Form.
- 2. The Company has also published an advertisement in one English Newspaper i.e., "Financial Express" and in one Regional Newspaper (Malayalam) i.e., "Janmabhumi" on 13<sup>th</sup> August, 2016 about the dispatch of the Notice and Postal Ballot Forms of required under the provisions of Section 110 of the Companies Act 2015 (as with Rule 22 of the Companies (Management and Administration) Rules, 2014.

- 3. In terms of the aforesaid notice, members were required to convey their assent / dissent, as the case may be on or before 12<sup>th</sup> August, 2016 in respect of the Special Resolutions as set out in the Notice of Postal Ballot dated 4<sup>th</sup> July, 2016:
  - In case of Postal Ballot Forms mailed to them by the Company in pre paid envelopes addressed to me on or before 12<sup>th</sup> August, 2016
  - In case of e-Voting, votes to be cast electronically on e-Voting platform provided by Karvy Computershare Private Limited on or before 12<sup>th</sup> August, 2016 before 5.00 p. m.
- 4. I received 41 Postal Ballot forms and 103 members casted their vote on the e-Voting Platform, till 12<sup>th</sup> August, 2016, being the last date for receipt of duly completed postal ballots forms and e-Voting on Karvy portal, as per the said notice.
- 5. With the support of Karvy Computershare Private Limited, the Registrar and Share Transfer Agents of the Company the Postal Ballot Forms were scrutinized and signatures of members who had cast their votes were verified with their specimen signatures registered with the Company and as provided by the Depositories.
- 6. In case of e-Voting, Members' demographic details, their voting rights and voting pattern were provided by Karvy Computershare Private Limited.
- The votes, if any, cast by member(s) both in physical form and e-Voting have been identified, in terms of the said Notice, votes cast through Physical forms were considered valid.
- I have downloaded the e-Voting Report from Karvy website by using the Scrutinizer's Login ID and Password on 13<sup>th</sup> August, 2016.
- 9. All the ballot forms received / votes casted in e-Voting website of Karvy upto the close of working hours i.e., 5.00 p.m. on 12<sup>th</sup> August, 2016 being the last date and time fixed by the Company for receipt of the forms were considered for scrutiny.
- 10. No Envelopes containing the Postal Ballot Forms were received after 5.00 p. m., on 12<sup>th</sup> August, 2016.

- 11. No Postal Ballot Forms were returned undelivered and there are no defaced / mutilated ballot papers.
- 12. After the aforesaid scrutiny of the Postal Ballot Forms and taking into account the e-Voting results, I report that the Special Resolutions as contained in the said Notice has been passed with requisite majority.

I have annexed with this Report, the details of the Postal Ballot and e-Voting and the analysis of the Results of the Special Resolutions as contained in the said Notice.

Accordingly, out of the 48,717,755 votes polled both in physical ballot and e-voting platform:

- 40,030 votes are invalid representing 0.082% of the total votes polled
- 48,271,036 votes are casted for the resolution representing 99.083% of the total votes polled
- 406,689 votes are casted against the resolution representing 0.835% of the total votes polled

Thus, the Special Resolution for Further issue of Equity Shares on Preferential basis as contained in the Notice dated 4<sup>th</sup> July, 2016 has been passed with Requisite Majority as required under the provisions of the Companies Act, 2013.
