Notes on unaudited standalone financial results:

 The above unaudited Standalone Financial Results for the Quarter ended 30 June, 2016 have been reviewed on 11 August 2016 by the Audit Committee and approved by the Board of Directors. These results have been subjected to limited review by the statutory auditors of the company.

These results along with the Review Report of the Statutory Auditors have been filed with Stock Exchanges, pursuant to Regulations 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and are available on the stock exchange website, NSE website (www.nseindia.com), BSE website (www.bseindia.com) and on company's website (www.mindagroup.com).

- 2) During the current quarter the following investments were made by the Company:
 - a) Additional 21,00,000 Equity Shares of Global Mazinkert, S.L. (wholly owned subsidiary) (face value of Euro 1 each) for a total consideration of Rs.15.97 crores.
 - b) 84,986 Equity Shares of Rinder India Private Limited (face value of Rs. 100 each) for a consideration of Rs. 39.68 crores, representing 99.99% holding in Rinder India Private Limited (RIPL). On completion of acquisition, RIPL has become subsidiary of the Company.
- 3) The Company is holding 70% equity in Minda Kosei Aluminum Wheel Pvt. Ltd., during the quarter the Company has further subscribed 1,96,00,000 equity shares of Rs. 10 each representing 70% equity of the total offer for a consideration of Rs. 19.60 crores. These Equity shares have been allotted on 13 July 2016.
- 4) On 21 May 2016, the Board of Directors, subject to the approval of the Shareholders and of the Hon'ble High Court have considered and approved the Composite Scheme of Arrangement, considering the merger of M J Casting Limited and demerger of international investment division of Minda Investments Limited and of Singhal Fincap Limited, with the Company. Subsequently, in view of further business developments Board of Directors on 11 August 2016 has approved the withdrawal of above Scheme of Arrangement.
- 5) On 28 June 2016 the Board approved, subject to the approval of Shareholders, the sub-division of equity shares of Rs. 10 each (fully paid up) into five equity shares of Rs. 2 each (fully paid up).
- 6) On 30 June 2016 the Company entered into Share Purchase Agreement with Panasonic Group for acquisition of 18,85,99,900 equity shares of Rs. 10 each of Panasonic Minda Storage Batteries India Private Limited representing 99.99% for a consideration of Rs. 1.80 crores (subject to adjustment of working capital on completion date). The completion of acquisition is expected by 31 August 2016.

The long stop date of Joint Venture Agreement and Business Transfer Agreement dated 1 October 2014, is extended upto 31 August 2016. Due to above Share Purchase Agreement the battery business will be operated by the Company or by Minda group and hence it is not treated as a discontinuing operation.

- 7) Tax expense includes Current Tax (including Minimum Alternate Tax) and deferred tax.
- 8) The Company is engaged in the business of manufacturing of auto components including auto electrical parts and its accessories and there is no separate reportable business segment as per Accounting Standard (AS-17) on Segment Reporting.





- 9) The figures for the last quarter of the previous year are the balancing figures between the audited figures for full financial year and the published year to date figures upto the third quarter of the previous financial year.

We did not review the total revenues of Rs. 349.55 crores and profit before tax of Rs. 5.58 crores and Company's share of profit of associates of Rs. 2.85 crores included in the accompanying unaudited consolidated financial results in respect of thirteen subsidiaries (including downstream subsidiaries), one subsidiary's jointly controlled entity and three associates, whose financial results have been reviewed by other auditors and whose reports have been furnished to us. Our conclusion, in so far as it relates to the amounts included in respect of such subsidiaries, subsidiary's jointly controlled entity and associates, is based solely on the review reports of the other auditors.
- 4. We did not review the total revenues of Rs. 10.30 crores and profit before tax of Rs. 2.60 crores and Company's share of loss of associate of Rs. 0.09 crores included in the accompanying unaudited consolidated financial results in respect of two subsidiaries (including downstream subsidiary) and two associates, whose financial results have been certified by management and have been furnished to us. Our conclusion, in so far as it relates to the amounts included in respect of such subsidiaries and associates, is based solely on the financial results certified by the management.
- 5. Figures for the corresponding quarter ended 30 June 2015 has not been reviewed by us.



6. Based on our review conducted as stated in paragraph 2 above and based on consideration of the review report of the other auditors referred to in paragraph 3 and financial results certified by management referred to in paragraph 4 above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited consolidated financial results prepared in accordance with applicable accounting standards and other recognised accounting practices and policies has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.
