
Re: **LIMITED REVIEW REPORT ON UNAUDITED FINANCIAL RESULTS

We have reviewed the accompanying statement of unaudited financial results of SIMPLEX CASTINGS LTD. for the quarter ended 30th June, 2016 except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors.
