Pursuant to Regulation 29(2) read with 29(3) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, we hereby make the requisite disclosures in the prescribed format with respect to the change in shareholding of GMR Enterprises Private Limited (the Company), pursuant to the Scheme of Amalgamation and Arrangement between GMR Holdings Private Limited (GHPL, Transferor Company 1 and the existing Holding Company of GMR Infrastructure Limited (GIL), and GMR Projects Private Limited (Transferor Company 2) with GMR Enterprises Private Limited (Transferee Company) approved by the Hon'ble High Court of Madras vide its Order No. 8471/16 dated July 06, 2016.

It may be noted that the above referred change in shareholding of the Company is only on account of the said Amalgamation and the consequent transfer of the shareholding of GIL from GHPL to the Company and there is no change in the overall Promoter holding, including the Persons Acting in Concert.

Subsequent to the said Order, GMR Enterprises Private Limited holds in aggregate 2,87,54,72,962 shares (i.e., 47.64%) in GIL.
