*Dear Sirs,*

- (1) We have been appointed as Scrutinizer by the Company for conducting the postal ballot and e-voting process in a fair and transparent manner in terms of the resolution of Board of Directors of the Company dated 28<sup>th</sup> June, 2016.
- (2) The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to e-voting and postal ballot on the resolutions contained in the Notice of the postal ballot and e-voting dated the 5<sup>th</sup> July, 2016. Our responsibility as a scrutinizer for the voting process through electronic means and postal ballots is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the e-voting system of National Securities Depository Limited (NSDL) and of voting received through postal ballots as provided by M/s Niche Technologies Private Limited, Kolkata the agencies engaged by the Company to provide e-voting / postal ballot facilities.
- (3) We submit our report as under :
  - (a) The Company has completed the dispatch of physical postal ballot forms (containing e-voting instructions) along with postage prepaid self-addressed envelope and postal ballot (containing e-voting instructions) via electronic mode by 5<sup>th</sup> day of July, 2016 to its Members whose name(s) appeared on the Register of Members / list of beneficiaries as on the 24th day of June, 2016.
  - (b) The postal ballot forms were kept under our safe custody in sealed and tamper proof ballot boxes.
  - (c) The ballot boxes were opened after 5 p.m. on Thursday, 4<sup>th</sup> day of August, 2016, in our presence.



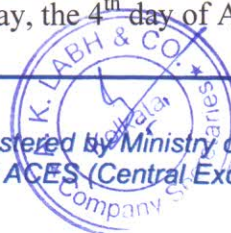




- (d) The postal ballot forms were duly opened in our presence and scrutinized.
- (e) Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.
- (f) All postal ballot forms received on or before 5 p.m. on Thursday, 4<sup>th</sup> day of August, 2016, the last date as fixed by the Company for receipt of the forms, were considered for our scrutiny.
- (g) Envelopes containing postal ballot forms received after 5 p.m. on Thursday, 4<sup>th</sup> day of August, 2016, *if any*, were not considered for our scrutiny.
- (h) We did not find any defaced ballot paper.

- (k) The e-voting period remained open from 9:00 A.M. IST on Wednesday, the 6<sup>th</sup> day of July, 2016 up to 5:00 P.M. IST on Thursday, the 4<sup>th</sup> day of August, 2016.





- (l) The Shareholders holding shares as on the “cut off” date, i.e. 24<sup>th</sup> day of June, 2016 were entitled to vote on the proposed resolutions as mentioned in the notice of the postal ballot and e-voting dated 5<sup>th</sup> day of July, 2016.
- (m) The result of the electronic voting was downloaded after 5 p.m. on Thursday, 4<sup>th</sup> day of August, 2016 from NSDL website providing the platform for e-voting system ([www.evoting.nsdl.com](http://www.evoting.nsdl.com)) and were unblocked in the presence of two witnesses, namely, Mr. Raju Chowdhury, residing at The C.A.B. 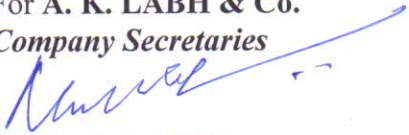
