Garware-Wall Ropes Q1FY17 PAT jumps 35% to Rs. 19.8 Crores

Pune, August 10, 2016: Garware-Wall Ropes Ltd. (GWRL), a leading manufacturer of technical textiles for the Indian and global markets, today announced its financial results for the first quarter ended June 30th, 2016.

Q1FY17 Highlights:

- Sales revenue was Rs. 225.06 Cr in Q1FY17 as compared to Rs. 239.32 Cr in Q1FY16
- Profit before tax grew by 31.1% to Rs. 28.40 Cr in Q1FY17 as compared to Rs. 21.66 Cr in the same quarter last year
- Net profit has grown by 35.1% to Rs. 19.76 Cr in the quarter as against Rs. 14.62 Cr in the corresponding period of FY16
- EPS for the period is at Rs. 9.03 in Q1FY17; this is a growth of 35.1% over Q1FY16

Management Comments:

Speaking on the results, **Mr. Vayu Garware, CMD, Garware-Wall Ropes Ltd.** said, *"We have seen robust growth in domestic markets but a subdued growth in exports due to deferment in purchases by our customers. This coupled with lower commodity prices have impacted top line growth. However, profit growth continues to be as per expectation and the margins are improving significantly due to the growth of our differentiated value added products in both domestic and international markets. We expect to see an uptick in exports in the coming months thus aiding our overall growth"*

Most recently the company received an upgrade from the credit rating agency ICRA to (ICRA) AA- from (ICRA) A+ basis the long-term facilities availed by the company.
