#### SCRUTINIZER'S REPORT

Subject: Scrutinizer's Report on voting through Postal Ballot (remote e-voting and postal ballot papers) pursuant to Section 108 and 110 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014

#### Dear Sir,

- I, **Sachin Khurana**, Company Secretary in Whole time Practice, was appointed as a Scrutinizer by the Board of Directors of M/s Rollatainers Limited at its meeting held on August 04, 2016 for the purpose of:
- i) Scrutinizing the remote e-voting process under the provisions of Section 108 of the Companies Act, 2013 ("Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended ("Rules") and;
- ii) Votes through postal ballot papers under the provisions of Section 110 of the Act read with Rule 22 of the Rules, on the resolutions contained in the notice of the Postal Ballot of the shareholders of the Company.
  - 1. The Company had appointed Central Depository Services Limited (CDSL) to provide the facility of remote e-voting with respect to voting by electronic means for the Postal Ballot.
  - 2. As per the said rules, the Company had mentioned in the Notice that the remote e-voting period will commence on 09.08.2016 (10:00 a.m.) and will end on 07.09.2016 (5:00 p.m.).
  - 3. The shareholders holding shares as on "cut off" date i.e. 05.08.2016 were entitled to vote on the proposed resolutions.
  - 4. The Public advertisement with respect to dispatch of notices and conducting of voting through electronic means was published in an English Newspaper of wide circulation and a vernacular newspaper on 09.08.2016.
  - 5. At the end of the voting period on 07.09.2016 (5:00 p.m.), the voting portal was blocked by CDSL. Subsequently, the votes cast through e-voting facility were duly unblocked by me as the Scrutinizer in presence of two witnesses.
