हिजाब पहने मांओं को स्कूल में रोका

मार्शिले।एएफपी। फ्रांसीसी द्वीप कोर्सिका में हिजाब पहने होने के कारण दो मुस्लिम मांओं को अन्य बच्चों के माता पिता ने नर्सरी स्कूल में प्रवेश करने से रोक दिया गया। पुलिस ने बताया कि यह घटना सोमवार को हुई। द्वीप के दक्षिणी हिस्से में स्थित बोनिफासियो में स्कूल शुरू होने पर माता पिता अपने बच्चों को छोड़ने के लिए स्कुल आए थे। स्थानीय प्रोसिक्यूटर एरिक बोलिवर्ड ने कोर्स मेतिन समाचारपत्र में छपी खबर की पृष्टि करते हुए बताया कि दोनों मुस्लिम महिलाओं ने हिजाब पहना हुआ था और दो लोगों ने उन्हें स्कूल में प्रवेश करने से रोक दिया। उनका कहना था कि जब उनके बच्चों को स्कुल के भीतर अपने धर्म से जुड़े प्रतीकों को पहनने की इजाजत नहीं है तो ये महिलाएं हिजाब पहने कैसे स्कुल में प्रवेश कर रही हैं। बोनिफासियो मेयर ज्यां चार्ल्स ओरसुसि ने बताया कि उनके शिक्षा अधिकारी को स्कूल में सामान्य रूप से प्रवेश की अनुमित देने के लिए मामले में हस्तक्षेप करना पड़ा। बोलिवर्ड ने बताया कि पुलिस और स्कूल इंस्पेक्टर को घटनास्थल पर भेजा गया और उन्होंने स्थिति को शांत किया। वहां कोई हिंसा नहीं हुई, न किसी ने धमकी दी और न ही कोई कानून तोड़ा गया। फ्रांसीसी स्कलों में छात्रों और अध्यापकों के लिए धार्मिक प्रतीकों को पहनने पर प्रतिबंध है लेकिन माता पिता पर ऐसी कोई रोक नहीं है। आयोग में अन्नानःविरोध तेज

म्यांमार।रायटर। म्यांमार में बहुसंख्यक बौद्धों और अल्पसंख्यक रोहिंग्या मुसलमानों के बीच विवादों के समाधान के लिए संयुक्त राष्ट्र के पूर्व महासचिव कोफी अन्नान के नेतृत्व में बने सलाहकार आयोग के विरोध में मंगलवार को देश के पश्चिमोत्तर में स्थित राखिनी प्रांत में सैंकड़ों लोगों ने रैली निकाली। लोकतंत्र समर्थक नेता आंग सान सू की ने मानवाधिकारों के प्रति अपनी प्रतिबद्धता दिखाते हुए अन्नान के नेतृत्व में एक समिति का गठन किया लेकिन स्थानीय लोग इस समिति में विदेशी (अन्नान) नागरिक के होने का विरोध कर रहे हैं। एक प्रदर्शनकारी ने कहा, हम इस आयोग में किसी विदेशी को नहीं देखना चाहते हैं, हम चाहते हैं कि इस समिति में राखिनी के लोगों को रखा जाए।

गौरतलब है कि देश में ज्यादातर रोहिंग्या मुसलमानों को नागरिकता प्राप्त नहीं है और वे बुनियादी सुविधाओं से भी वंचित हैं।

बैनरों में दिखा एमक्यूएम में सता का झगड़ा

पुलिस ने सिंध उच्च न्यायालय की इमारत एवं सद्दार क्षेत्र के बाहर बैनर लगाने वाले लोगों की तलाश शुरू कर दी है। इन बैनरों में कहा गया है कि मृत्तहिदा कौमी मूवमेंट (एमक्यूएम) के प्रमुख अल्ताफ हुसैन के साथ बगावत करने वालों को मार दिया जाना चाहिए।

उच्च सरक्षा क्षेत्र में पड़ने वाली उच्च न्यायालय की इमारत के बाहर लगे बैनरों में कहा गया है कि एमक्यएम नेता के साथ बगावत करने वाले को मार दिया जाना चाहिए। इसके कुछ ही घंटों बाद सद्दार के रीगल चौक इलाके में एमक्यूएम नेता फारुक सत्तार और उनके साथियों को बागी बताते हुए बैनर लगाए गए। बैनरों में 22 अगस्त को कराची प्रेस क्लब के बाहर एमक्युएम के एक भुख हड़ताल शिविर में पाकिस्तान विरोधी बयानों के कारण अल्ताफ हुसैन के खिलाफ पिछले सप्ताह कौमी असेंबली में एक प्रस्ताव को सर्मथन देने वाले पार्टी नेताओं को धमकी दी गई है। सिंध पुलिस के महानिरीक्षक ए डी ख्वाजा ने जातीय घृणा फैलाने वालों के खिलाफ कड़ी कार्रवाई करने का भरोसा दिलाते हुए कहा कि हम मामले की जांच कर रहे हैं और धमकी भरे बैनर लगाने वालों की तलाश कर रहे हैं। उन्होंने कहा कि बैनरों एवं दीवार पर चॉक से लिखकर दी गई धमिकयों में एक अज्ञात समूह 'जानशीन बानी ए एमक्यूएम' का नाम लिखा गया है। पुलिस ने टेलीविजन चैनलों पर समाचार दिखाए जाते ही उच्च न्यायालय के बाहर से जल्द बैनर हटा दिए लेकिन बाद में सदर इलाके में बैनर मिले और कई जगहों पर दीवार पर चॉक से लिखी धमिकयां मिली। एक राजनीतिक विश्लेषक मजहर अब्बास ने कहा कि एमक्यूएम और उसके प्रमुख अल्ताफ हुसैन के बीच सत्ता संघर्ष चल रहा है। हुसैन उन नेताओं को पार्टी की कमान सौंपने के इच्छुक नहीं हैं जिन्होंने घोषणा की है। कि अब वे एमक्यूएम पाकिस्तान का नेतृत्व कर रहे हैं और लंदन से कोई आदेश नहीं लिया जाएगा।

थाइलैंड में जीका के खिलाफ अलर्ट

बैंकॉक।भाषा। बैंकॉक में दो महिलाओं में जीका का इनफेक्शन पाया गया है। इस खतरे को लेकर एलर्ट जारी करते हुए थाइलैंड के स्वास्थ्य अधिकारियों ने इसके फैलाव पर निगरानी बढ़ा दी है। मेट्रोपोलिटन एडमिनिस्ट्रेशन ने कहा कि इस साल एक जनवरी से चार सितंबर तक राजधानी में जीका वायरस के आठ मामले सामने आए। इनमें दो मामले गर्भवती महिलाओं के थे।
