Proceedings of the **Twenty Seventh Annual General Meeting** of M/S.Gangotri Textiles Limited held on **Wednesday, the 21<sup>st</sup> day of September, 2016** at 3.30 P.M at Bimani Hall, Coimbatore Gujarat Samaj, 662 Mettupalayam Road, Post Box No 1164, R.S.Puram, Coimbatore – 641 002

Sri.Manoj Kumar Tibrewal was elected to be the Chairman of the meeting and he presided. Before the commencement of the meeting, the Chairman introduced the Director present on the dais.

Then the Chairman informed the members present that the Register of Directors' Shareholding maintained under section 307 of the Companies Act, 1956 is being kept open for inspection for the members who may desire so to do.

The Notice convening the meeting was taken as read. The Chairman stated that with the permission of the members present, the Financial Statements ie the Balance Sheet as at 31<sup>st</sup> March, 2016, the Profit & Loss Account for the year ended 31<sup>st</sup> March, 2016 and the Directors' Report which have been in the hands of the shareholders for the past 4 to 6 weeks may be taken as read.

The Report of the Auditors for the year ended 31<sup>st</sup> March,2016 was read at the meeting. Then the Chairman informed that members may express their views if any. Three Members have expressed their views that the main culprit for the sickness was putting Processing House –which needed deep pocket to withstand stabilization period. Another Member expressed that the Lenders should not have given so much high geared loan. Chairman said that the Lenders should not be blamed. The Company should admit its own mistake to go for such high leveraged project. He also explained that at that time there were several favourable factors like low interest rates , opportunity provided by dismantling of quota etc. However, subsequent events like hike in interest rates, Global recession and severe power-cut in Tamil Nadu which brought the company to the present position.

Then the Chairman announced that the results by the Scrutinizer appointed for the purpose in terms of the provisions of the Companies Act, 2013. in respect of the assent/ dissent given by the Shareholders on each resolution will be known to the shareholders as soon as the same is received. 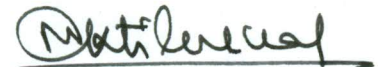
