Krishiraj Trading Limited, Welspun Mercantile Limited and Welspun Wintex Limited ("Transferors"), promoters of the Target Company, collectively held 69.93% voting rights in the Target Company. Pursuant to a court approved scheme of arrangement ("Scheme") under the provisions of Companies Act, 1956 / 2013 not directly involving the Target Company, the Transferors have been merged / amalgamated with MGN Agro Properties Private Limited ("Acquirer"). The Scheme has been approved by the High Court of Gujarat on 8th July, 2016 and has come into effect on September 27, 2016. Pursuant to the

Scheme coming into effect, the (i) 69.93% voting rights held by the Transferors in the Target Company stand vested in the Acquirer, and (ii) Transferors have ceased to exist. Accordingly, this filing is being made upon the acquisition of such voting rights by the Acquirer under the Scheme. In terms of Regulation 10(1)(a)(iii) and Regulation 10(1)(d)(iii) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, such acquisition of voting rights by the Acquirer is exempt from an obligation to make an open offer under Regulation 3 and Regulation 4 of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011.
