# Gist of the proceedings of the Annual General Meeting Of La Tim Metal & Industries limited (Formerly known as Drillco Metal Carbides Limited) held on Saturday, September 24, 2016

The 40<sup>th</sup> Annual General Meeting of the Members of the Company was held on Saturday, September 24, 2016 at 11.00 a.m. at the Registered Office of the Company at 301, Navkar Plaza, Bajaj Road, Vile Parle (West), Mumbai - 400 056.

Mr. Kartik Timbadia chaired the proceedings of the Meeting. Total 17 Members attended the Meeting in person as per the records of attendance.

The Chairman gave an overview of the financial performance of the Company for the financial year ended March 31, 2016 and its future outlook.

The Chairman informed the Members that pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had extended the e-voting facility to the Members of the Company in respect of businesses to be transacted at the Annual General Meeting.
