

Gist of proceedings of the 24th Annual General Meeting of ISL Consulting Limited

The 24th Annual General Meeting (AGM) of the members of the Company was held on Tuesday, September 27, 2016 at 11:00 AM at 404, Aniket Building, Nr. Municipal Market, C.G. Road, Ahmedabad-380009.

Mr. Ankit J. Shah chaired the proceedings of the Meeting. Except Mr. Hitesh C. Kothari, Managing Director, all the directors, Chief Financial Officer and Company Secretary were present at the meeting. After declaring the quorum to be present, the Chairman called the meeting to be in order.

With the consent of the Members, the notice convening the 24th Annual General Meeting was taken as read, since there was no qualification, adverse remark or observation in the Independent Auditor's Report, the same was taken as read.

The Chairman then informed the Members that in compliance with the provisions of the Section 108 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 as amended and Regulation 44 of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company has provided to Members the facility to exercise their vote through electronic means. The remote e-voting facility was commenced at 9:00 A.M. on Friday, 23rd September, 2016 and ended at 5:00 P.M. on September 26, 2016.

The Chairman then informed that Members who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes in the Ballot Box at the end of the meeting. It was further informed that there would be no voting by show of hands.

Mr. Keyur J. Shah and Associates, Practicing Company Secretaries, Ahmedabad were appointed as scrutinizer for the purpose of scrutinizing the remote e-voting process and voting at AGM in fair and transparent manner.

- 4) Appointment of Mr. Ankit J. Shah (DIN: 02695987) as Managing Director of the Company.
- 5) Appointment of Mr. Sandeep K. Thacker (DIN: 07484448) as Independent Director of the Company.
